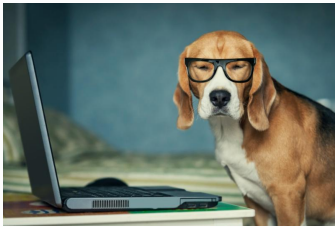

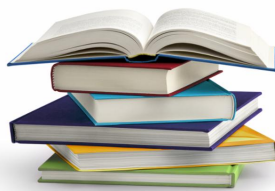

Choose the version of the calendar that matches your daily work calendar and it will be added as a separate calendar of events!

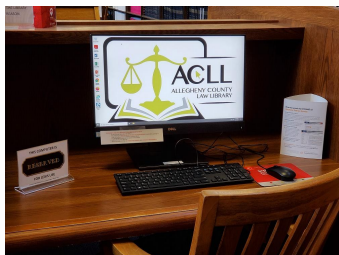
