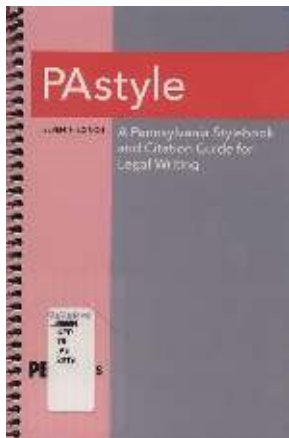

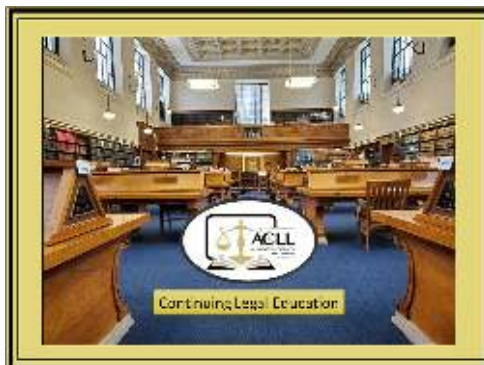


Landlord / Tenant CLE / Workshop

Paul Recht, age 75, of Squirrel Hill, passed away on September 22, 2021. He is survived by his beloved wife, Meredith (Kern) Recht, to whom he was married thirty-seven years. Son of the late Herman and Esther Recht, Paul was a life-long Pittsburgher who attended the Falk School and Taylor Alderdice High School. Educated at both the University of Chicago and the University of Pittsburgh, he obtained a degree in Library Science and worked at the Pitt Bookstore before securing a position at the Allegheny County Law Library. In his forties, Paul obtained a law degree at Duquesne University, graduating in 1992. He remained employed with Allegheny County until his retirement in 2019. Paul rooted for the Steelers, Pirates, and Penguins. He attended the original Woodstock Music and Arts Fair in 1969 and had a particular fondness for the music of Bob Dylan. He and Meredith were devoted members of the North Shore's Allegheny Center Alliance Church and Congregation Yeshua Ben David. Paul is also survived by a loving group of cousins, nieces, nephews, and in-laws, all of whom will miss him. Paul will be privately interred in Green Ridge Memorial Park, Connellsville, PA.
