Secondary Legal Sources may restate the law, but they also discuss, analyze, describe, explain, or critique it as well. These include reference works such as **dictionaries and encyclopedias**, **books**, **treatises**, **theses and dissertations**, **journal articles**, **loose-leaf publications**, **indexes and abstracts**.

Treatises, not to be confused with treaties, are **book-length expositions on the law as it pertains to a particular subject**. Treatises may be scholarly in nature, such as Murray on Contracts, or they may be geared toward a legal practitioner, such as a manual or handbook.
